Sara - Rules Interpretation

1. *White #3 is carded for a check to the head in the midfield. She expresses her dissatisfaction and is subsequently carded again for her dissent. What is the proper card*

- and player management for that situation? The carded player is off for 2 minutes. The coach selects another player to serve 2 minutes. They play 2 players down for 2 minutes. Someone else can come in but she cannot.
2. She expresses her dissent the call with vulgar language. She gets a subsequent red. Player #5 (coach selected) is in the box for 2 minutes and return. Player #3 will stay in the box for an additional 2 minutes and at that point her time is served but she may not return to the game.
 3. If this is the teams 4th card then no one would come in for her when the time elapses.
 4. A girl gets a yellow card. Goal is at 23:08 and the goal is scored at 21:09 the carded player is observed on the field with 1 second still on for the card foul. What do you do? She goes back and serves the rest of that card, plus another 2 minutes. Could it be solved by talking between each other? Yes. But had she entered during live play, then she is gaining and advantage. But because she caught it while it was still a dead ball situation she hasn't really done anything wrong yet.
 5. You are officiating a game with white wearing all white undergarments. The away team is wearing black and mostly black undergarments but a few are wearing navy blue. What is the penalty? They either have to get correct it and get legal and wear the same undergarments or it is a one time possession given to the other team. The spirit of the rule is to not make our jobs more difficult.
 6. In YAGLA they are not required to have numbers in the front and back. Undergarments don't matter if they match. It's for learning and having fun.
