# YAGLA (Youth)

- K-2 Revision
  - All players must stay out of the goal circle until the referee instructs a player to go get a ball that has come to rest in the circle, but has not crossed the goal line.
- Pass Rule Revisions & Clarifications
  - Goalie clears DO NOT count as a pass for the YELLOW division.
  - Goalie/deputy clears **DO** count as a pass for the GREEN & K-2 divisions
  - A team's pass count will only reset if the ball crosses back to their defensive side of the field. (Not a gotcha call)
  - A team is free to make pass attempts anywhere on the field
  - SUBSEQUENT TURNOVERS: If subsequent turnovers occur without the ball crossing midfield, a team's previously established pass count will RESUME.
    - EXAMPLE: The White team has met their required number of passes. White #3 drops the ball and it is picked up by Black #9. Black #9 attempts to pass the ball to a teammate but it is intercepted by White #33. The ball has NOT crossed mid-field. White is free to go to goal.

## **Rules Interpretation - Sara**

- Final Interpretation: Rule 12.6.1 A The bulletin is wrong. Administer the foul as written in the NFHS rule book (a second player should be pulled for the second card and both cards will be administered simultaneously for two minutes.) A retraction to the interpretation published in the last two bulletins will not be made. Karen Blaine replied with the interpretation that the cards were originally back to back but when questioned it our interpretation was the correct interpretation. Refer to this rule and the cards are given simultaneously. In NCAA they do stack them. That is a part of the confusion. See page 72.
- Goalies get carded too. If there is a 2nd dressed goalie, the carded goalie is sent to the box, along with another field player selected by the coach. The replacement goalie is placed behind the 8m or dot FP depending on where the foul occurred. If there is no other dressed goalie, the coach will select a field player to serve the card but the goalie may remain in the game. Goalie is placed behind the 8m or dot FP depending on where the foul occurred.
